What is Main Street Dandridge?

In 2006, Dandridge became one of 21 communities certified as a Tennessee Main Street community, which is a program supported by the National Trust for Historic Preservation and the Tennessee Department of Economic & Community Development.

The **Dandridge Community Trust** is a local organization that is responsible for the Main Street Dandridge program. It is run by a volunteer board, an Executive Director, and those who volunteer for special projects.

In order to keep our status as a Main Street program, we must get recertified every year by the State and the National Trust, which evaluates our ongoing commitment to our community.

- Preserve and leverage the historic architectural and cultural heritage of the town center.
- Develop a sound economic base that meets the needs of residents and businesses.
- Build strong alliances and a high level of cooperation among all groups with a stake in the future of the community.



Dandridge, Tennessee, is the only community named after First Lady Martha Washington, née Martha Dandridge.
